Dr. Jim Williams moved to approve the changes to Policy 6.36 with the additional change of wording on page two, last paragraph to read: 'Violation of this policy <u>may</u> result in the student being reported to the appropriate law enforcement officials, in accordance with state law. Violation of this policy <u>may</u> result in the student being suspended or expelled.' Pat Wiederholt seconded. The motion unanimously passed.

- C. Approval of changes to Policy 7.01 Policies Against Harassment, Sexual Misconduct, Sexual Violence and Discrimination.
  - Old Policies 3.19 and 6.27 will now be found under Policy 7.01
  - Policy 7.01 applies to all faculty and students.

Pat Wiederholt moved to approve the changes to Policy 7.01 with the changes of wording on page 13, the last sentence under subtitle "Bullying" to read: 'Students who violate the bullying prohibition <u>may</u> be reported to local law enforcement.' and change the title of 7.01 to coincide with the order of the subtitles. Ken Roemer seconded. The motion unanimously passed.

D. Approval to adopt Policy 7.02 – Student Pregnancy Policy

Upon a motion made by Pat Wiederholt to adopt Policy 7.02, seconded by Dr. Jim Williams, the motion unanimously passed.
