TECHNICAL HLC Visit Quick Guide for Students

The Higher Learning Commission (HLC), FHTC's Accreditation Process, and the **Comprehensive Evaluation**

What is the Comprehensive Evaluation?

The Comprehensive Evaluation (Site Visit) by the Higher Learning Commission (HLC) occurs as part of the College's cycle of accreditation. HLC last visited the FHTC campus in the spring of 2016. Site visit teams are a group of volunteer peer professionals (faculty, staff, administrators, etc.) from other colleges in our regional accrediting system. There are typically five representatives that will be on campus, but COVID may impact their in-person attendance so some elements may be conducted virtually.

FHTC's evaluation is scheduled on September 13 & 14,2021

More information will be provided the week before the scheduled visit.

What happens during the visit?

Over the past year, faculty and staff of FHTC have been preparing the Assurance Argument which details and provides evidence on how FHTC conducts business and meets the mission of the college. This document is extensive and covers five key areas related to operations: 1) mission: 2) governance, ethics and integrity: 3) support resources for teaching and learning; 4) assessment of teaching and learning; and 5) planning and use of resources. This document is available to anyone who is interested in reading it by emailing dgilligan@fhtc.edu to request a copy.

The site visit team will read the assurance argument before they arrive on campus and this review will guide what areas of the institution they will want to gather more information on. The site team along with FHTC administration will determine a schedule to meet with various stakeholders.

Preparing for the Site Visit

Why is accreditation important?

Accreditation is vitally important not only to the college overall but to each student who attends FHTC. The College received initial accreditation by HLC in 2007; this process affirms and continues the accreditation.



Reaffirming accreditation from the Higher Learning Commission (HLC) ensures that:

Students have access to Federal Financial Aid funds to attend school at FHTC Students can transfer the credits earned at FHTC to other accredited Institutions of Higher Education. FHTC programs are validated in their level of rigor and academic expectation for the level of degree awarded.

How can I prepare for the Site Visit?

There are several ways that you can prepare for the Site Visit:

- 1. Know that the site visit team will be on campus and mark your calendars for September 13 & 14
- 2. If you encounter a team member, please be as helpful as possible and provide any assistance needed. The team has a very large amount of work to do in a very short amount of time and we
- want to be as responsive as possible. If you do not know the answer to a question that may be posed to you, that is okay. It is important to be honest when responding to questions. 3. Plan to attend the "Pizza with Students" meeting on September 13, at 11:30 AM. Consider attending one of the open forums or possible drop-in sessions. The dates and times will be posted prior to the visit.

Do you know FHTC's mission?

A mission is the guiding statement about the goals, values, and priorities of an institution. FHTC is expected to communicate this statement to all stakeholders. Do you know what FHTC's mission statement is- or do you know where it is posted for you to read?

The core values are the areas that should guide decision making within the college. Site visit team members may ask you if the college reflects the stated values. These Core Values are bulleted below:

- · Quality in all aspects of its operation.
- Diversity of all individuals and mutual respect within the framework of ethical behavior.
- · Student success by providing a wide range of support services in a caring climate conducive to student learning and campus safety.
- Innovation accomplished through the vision and creativity of all partners in technical education.
- Hands on education that leads to technical skills attainment.
- · Accessibility of education by providing a variety of delivery methods.
- Collaboration with internal and external stakeholders.

Leadership, Planning, & Decision Making

Another key area is related to shared governance of the college. It is important the student body of the college has a voice in the leadership and decision-making process. What are some ways that FHTC includes the student voice? Have you been asked to participate in evaluations, surveys, or in other ways asked for input on campus operations or the future of FHTC?

Assessment & Learning

Assessment and learning are at the very heart of everything FHTC does to prepare students to be career ready upon graduation. You may be asked how information on student learning outcomes is communicated to you (Institutional Student Learning Outcomes [ISLOs], Program Learning Outcomes [PLOs], or Course Learning Outcomes [CLOs]). This type of information is often found on syllabi, in course catalogs, and on grading elements within classes.

• ISLOs: Do you know what skills FHTC states that all students in every program should have before graduating?

- · PLOs: Do you know what skills your instructors state you will have upon graduating with a technical certificate or associates degree?
- · CLOs: What about the skills that you should have when you complete your current course work?
