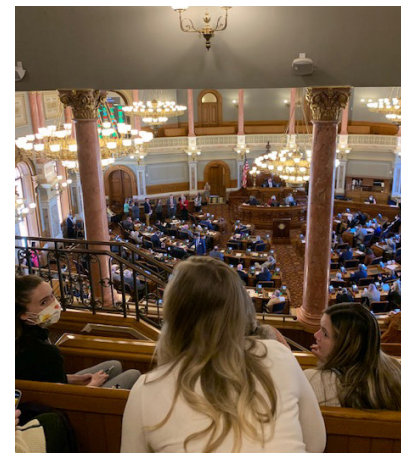

Dental Hygiene Students Engage in Advocacy

On January 19, senior Dental Hygiene students welcomed to campus Whitney Zamora, President of the Kansas Dental Hygiene Association (KDHA). She spoke about the importance of advocacy and working together in the legislative process and shared about the current proposed legislation to add a dental therapist in Kansas. When passed, a dental therapist would need to be a registered dental hygienist and complete an

additional two years of specialized training. The dental therapist would help reduce some of the access to care issues in Kansas.

Those students then attended the KDHA Advocacy Day at the Kansas Statehouse on January 26. They watched the legislative process, visited with their senators and representatives, meet KDHA lobbyist, and advocated for the dental therapy legislative bill.
