Income Information to Be Verified

The best way to verify income is by using the IRS Data Retrieval Tool (DRT) when completing or updating the FAFSA. If you did not use the tool, you must provide an IRS 2021 Tax Return Transcript <u>or</u> signed copy of your 2021 IRS Federal Income Tax Return (Form 1040, Schedules 1-3). A 2021 IRS Tax Return Transcript may be obtained through:

- <u>Get Transcript by MAIL</u> Go to <u>www.irs.gov</u>, click "Get Your Tax Record." Click "Get Transcript by MAIL." Make sure to request the "IRS Tax Return Transcript" and **NOT** the "IRS Tax Account Transcript."
- <u>Get Transcript ONLINE</u> Go to <u>www.irs.gov</u>, click "Get Your Tax Record." Click "Get Transcript ONLINE." Make sure to request the "IRS Tax Return Transcript" and **NOT** the "IRS Tax Account Transcript."

- <u>Paper Request Form</u> IRS Form 4506T-EZ or IRS Form 4506-T With the exception of "Get Transcript ONLINE," transcripts are generally received within 10 business days of the request.
