# 2024-2025 Independent Verification Worksheet - V1, V5

Your 2024-2025 FAFSA was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information we will compare your FAFSA with the information on this worksheet along with any other required documents. If there are differences, your FAFSA information may need to be corrected. You must complete and sign this worksheet, attach any required documents, and submit them to the FHTC Financial Aid office.

# Student's Family Information

Family Size: List the people in the student's family. Include the following:

- yourself.
- your spouse, if married.
- your dependent children if they live with you (or live apart because of college enrollment), they receive more than half of their support from you, and they will continue to receive more than half of their support from you from July 1, 2024, through June 30, 2025.
- other persons if they now live with you <u>and</u> receive more than half of their support from you, <u>and</u> will continue receive more than half of that person's support from you through June 30, 2025.

The provided criteria for "dependent children" or "other persons" align with the requirement that family size align with whom the student could claim as a dependent on a US tax return if the student were to file a US tax return at the time of completing the 2024-2025 FAFSA. As a result, the student should not include any unborn children in the family size.

# **Income Information to Be Verified**

As part of federal student aid eligibility, students, and spouses (if married), will be required to consent and approve sharing and importing income and tax information from the IRS to the FAFSA form, even if the attempt to obtain or use such data is ineffective. In other words, if the student and spouse filed separate 2022 IRS income tax returns, both must provide consent and approval to share and import income and tax information from the IRS. In most cases, no further documentation is needed to verify 2022 income information that was transferred into the student's FAFSA using income and tax information directly from the IRS. If 2022 income tax return information for the student (or spouse, if married) was not available or could not be used, the student should provide the institution with a 2022 IRS Tax Return Transcript(s) or a signed copy of the 2022 income tax return and applicable schedules. A 2022 IRS Tax Return Transcript may be obtained through:

- <u>Get Transcript by MAIL</u> Go to <u>www.irs.gov</u>, click "Get Your Tax Record." Click "Get Transcript by MAIL." Make sure to request the "IRS Tax Return Transcript" and **NOT** the "IRS Tax Account Transcript."
- <u>Get Transcript ONLINE</u> Go to <u>www.irs.gov</u>, click "Get Your Tax Record." Click "Get Transcript ONLINE." Make sure to request the "IRS Tax Return Transcript" and **NOT** the "IRS Tax Account Transcript."

- <u>Paper Request Form</u> IRS Form 4506T-EZ or IRS Form 4506-T With the exception of "Get Transcript ONLINE," transcripts are generally received within 10 business days of the request.
